PSAT/NMSQT stands for Preliminary SAT/National Merit Scholarship Qualifying Test.

It's a standardized test that provides firsthand practice for the SAT Reasoning Test™.

It also provides a chance to enter National Merit Scholarship Corporation (NMSC) scholarship programs.

To potentially qualify for the National Merit Scholarship Program students must score in approximately the top ½ of the top 1% in the nation.

**** Sophomores cannot qualify for the National Merit Scholarship Program.*

This test is a *co-sponsored* program by the College Board and National Merit Scholarship Corporation (NMSC).

The PSAT/NMSQT measures:

- * critical reading skills
- * math problem-solving skills
- * writing skills

Students take the PSAT/NMSQT to:

- * enter the competition for scholarships from the National Merit Scholarship Corporation (juniors only)
- * help prepare for the SAT by becoming familiar with the SAT format
- * assess their mastery of the skills necessary for college-level work
- * receive information from colleges
